NUSS Ordinary / Associate Membership Information

1. Eligibility

- Ordinary Membership is open to all persons who are on the Register of Graduates or have successfully completed any postgraduate degree from the National University of Singapore.
- Associate Membership is open to graduates of other recognised universities.
- Admission to NUSS is at the sole discretion of the Management Committee.
- Spouses may apply for Spouse Membership (Note: A Spouse Member is not entitled to any of the rights and privileges of members except those approved by the Committee).

2. Entrance Fee

- Applicants joining within 36 months (3 years) from the date of their first degree or postgraduate degree(s), provided such postgraduate degree(s) commence within 12 months after obtaining the first and subsequent full-time degree, shall pay an entrance fee of \$2,180 w/GST.
- Applicants joining between 36 and 72 months (4 to 6 years) from the date of their first degree or postgraduate degree(s), provided such postgraduate degree(s) commence within 12 months after obtaining the first and subsequent full-time degree, shall pay an entrance fee of \$2,725 w/GST.
- Applicants joining more than 72 months (6 years) from the date of their first or postgraduate degree(s) will be required to obtain membership at a fee of \$5,000 w/GST through the Secondary Transfer Market via NUSS.
- Applicants may pay the Entrance or Secondary Transfer Market fees in full or by the instalment plans set out below:

NUSS will refund the payment made in full within 60 days after the cancellation of the membership application.
